- 2. The Company will allow the shareholders to register for meeting attendance at least one hour prior the meeting is declared open or from 13.00 hrs. onward at the Gallery room on the 1st floor of the Company's headquarters building.
- 3. The company has set a distance of not less than 1 meter in attending the meeting and accommodates up to 40 seats for shareholders.  - c. Persons who travel, reside, or perform his duties in the control area. This includes persons who was presented in crowded area with the COVID-19 outbreaks.
- 5. The Company will not provide microphones. If there is a question, write it on paper provided only and send to our officers. The Company will answer the questions only related to the agenda that has been voted on. For other questions, the Company reserves the right to consider as appropriate.

- 7. The Company will not allow for moving or changing the seat throughout the Meeting.
